Spud well on 4/20/10. Drilled 12-1/4" hole to 400'. Landed 8-5/8" 24# J-55 csg @ 385'. Cmted lead w/175 sx (236 cf) C cmt w/2% Cacl2 & 1/4# p-e-flake. Tailed w/200 sx (270 cf) C cmt w/2% Cacl2. Circ 25 sx cmt to surface. On 4/22/10, PT 8-5/8" csg to 600 psi for 30 min - OK.

Drilled 7-7/8" hole to TD5265' on 5/5/10. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 5252'. Cmted lead w/550 sx (1045 cf) 35/65 poz C cmt w/0.125# p-e-flake, 3# salt, 0.5% Halad-9 & 3# gilsonite & tailed w/650 sx (878 cf) C cmt w/0.125# p-e-flake, 0.4% Lap-1, 0.5% CFR-3, & 1/4# D-air 3000. Circ 161 sx cmt to pit. Released drilling rig on 5/6/10. We plan to PT 5-1/2" csg during completion operations. *Before beginning*
