To return this well to active production, the following procedure was performed;

3/08/10 - Rig up pulling unit.

3/09/10 - Pull out of hole with rods/pump. Install BOP. Shut down.

3/10/10 - Pull out of hole with 37 stands of 2-3/8" tubing. Shut down due to high wind.

3/11/10 - Pull out of hole with 30 stands of 2-3/8" tubing. Located hole in 1 joint. Replace bad tubing, install new seat nipple and ran back in hole. Bottom of tubing ~4150 feet. Installed well head and flow line. Ran in hole with pump and rods, new wiper rubber. Rehang head & set stroke. Loaded with 3 bbls - pressure test OK.

3/12/10 - Rig down pulling unit.
