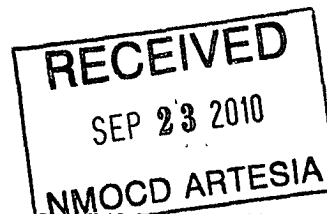

Spud well on 8/10/10 with 17-1/2" hole and drill to 430'. Run 13-3/8" casing on 8/11/10 as follows:

1 Texas Pattern Shoe 1'  
1 Jt. 13-3/8" 48# H-40 ST&C 43'  
1 Float Collar 2'  
9 Jts. 13-3/8" 48# H-40 ST&C 393'  
Total 439'

Set casing @ 430'. Cement –Tail w/470 SXS HalCem-C +2% CaCl – 14.8 ppg, 1.35 yield, 6.39 gal/sk. WOC 2 hrs. Cut off 13-3/8" csg, weld on wellhead. Nipple up BOP and test to 250 psi low and 3000 psi high. Test annular to 250 psi low and 1500 psi high. Held OK. WOC additional 20.25 hrs. Trip in hole w/ 12-1/4" bit and drill cement & float collar. Test casing to 600 psi. Resume drilling formation at 430'.
