

10/13/10 – Tagged CIBP at 7554'. Loaded and tested casing to 500 psi. Circulated hole with salt gel. Spotted 30 sx Class "H" Neat cement at 7554'. Calc TOC at 7369'. Spotted 35 sx Class "C" Neat cement at 5648'. Calc TOC at 5433'. Spotted 35 sx Class "C" Neat cement at 3570'. Calc TOC at 3295'. Spotted 35 sx Class "C" Neat cement at 2237'. Calc TOC at 2022'. Spotted 35 sx Class "C" Neat cement at 1148'. WOC. Tagged at 928'. Spotted 25 sx Class "C" Neat cement from 150' up to surface. ND BOP. Topped out casing with cement.

10/25/10 – Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar and cut anchors. Cleaned location. **WELL IS PLUGGED AND ABANDONED.**
