04/15-19/2010 Samples taken at location. Results ranged from 205 ppm - 132 ppm which are below NMOCD limits for chlorides. Moved top soil over location. Berm, contour and windrow area downsized to prevent erosion. Downsized area was seeded w/ BLM #2 & BLM #3 seed. Initial size of location 82,655'. Location area after downsizing 43,200'. (Total reclaimed area 39,455'.)

Site is ready for interim reclamation inspection.
