1. MIRU workover rig, POOH w/existing 2 7/8" tbg.
2. RIH w/3 1/2" WS and hudraulically fracture existing Morrow perforations. Flowback stimulation load allowing well to cleanup after stimulation.
3. POOH w/3 1/2" WS, RIH w/ 2 3/8" tbg carrying Y-block perforating assembly.
4. Latch onto existing 5 1/2" packer. Perforate Atoka from 11,239' - 11,252' and 11,255'-11,264' at 4 spf via Y-Block TCP system.
5. Return well to production with Morrow formation producing via 2 3/8" tbg and Atoka formation producing via 5 1/2" casing.
