1. MIRU Workover rig, POOH with existing 2-3/8 tubing and Packer assembly.
2. RIH setting 5-1/2 CIBP at 11,440 capping with 25' cement. 35'
3. RIH with 2-7/8 tubing carrying 5-1/2 packer with tubing conveyed perforating system.
4. Set 5-1/2 pkr @ +/- 8,450 and perforate Wolfcamp from 8,548 8,588 at 2 spf.
5. Return well to production with Wolfcamp producing up 2-7/8 tubing.
