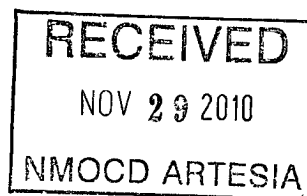

- 10-27-10 RIH w/wirline and perf'd csg @2181'. RIH w/pkr and set @1800'. Pressured up to 1000 psi. Release pkr. RIH w/tbg to 2231'. Spot 30 sx class C cement. Pull out of cement, WOC. Tagged plug @1890'. POH w/tbg to 1350'. Perf'd csg @1697'. Set pkr and pressured up to 1000 psi, released pkr and RIH w/tbg to 1764'. Spot 30 sx class C cement. Pull out of cement, WOC.
- 10-28-10 Tagged plug @1523'. POH to 400'. Perf'd @830'. Set pkr & squeezed 170 sx class C cement, did not circulate. Close well in and WOC. Tagged plug @550'. POH w/tbg, perf'd csg @60'. Squeezed 20 sx class C cement to surface. Cleaned location RDMO.
- 11-1-10 Cut off wellhead, welded on Dry Hole Marker. Back filled cellar, cut off dead men and cleaned location.
