13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. - 10/14/10 Loaded casing. Tested to 500 psi, good. NU BOP. Set a 7" 10K Alpha CIBP at 7702'. Capped with 3 runs of cement on top of CIBP to give 35'.
- 10/15/10 Tagged cement on top of CIBP at 7655'. Loaded hole with mud gel. Pumped 275 bbls. Pumped 60 sx Class "C" cement at 5681'. Est TOC at 5313'.
- 10/18/10 Tagged cement plug at 5403'. Pumped 25 sx Class "C" cement at 3451'. Est TOC at 3297'. Did not have to tag. Pumped 25 sx Class "C" cement at 2210'. Est TOC at 2056'. Did not have to tag. Pumped 40 sx Class "C" cement at 1177'. WOC 2 hrs. Tagged cement plug at 990'. Pumped 25 sx Class "C" cement plug from 149' up to surface. ND BOP. Topped well off with cement.
- 10/26/10 Dug out cellar and cut off wellhead. Had to put 20 sx cement down 8-5/8" casing. Installed dry hole marker. Filled cellar back in and dug up anchors. Cleaned location. WELL IS PLUGGED AND ABANDONED.

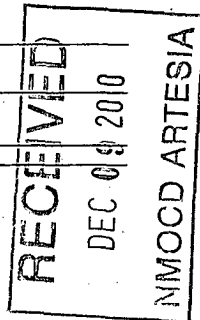
