- 10/13/10 Loaded and tested casing to 500 psi, good. NU BOP. Pumped 50 bbls down tubing. Set a 7" 10K Alpha CIBP at 7690'. Had to make 3 runs of cement on top of CIBP.
- 10/14/10 Loaded hole with mud gel. Pumped total of 275 bbls. Pumped 60 sx Class "C" cement at 5673'. Est TOC at 5305'. WOC 2 hrs. Tagged cement plug at 5342'. Pumped 25 sx Class "C" cement at 3473'. Est TOC at 3319'. Did not have to tag. Pumped 25 sx Class "C" cement at 2210'. Est TOC at 2056'. Did not have to tag. Pumped 40 sx Class "C" cement at 1145' across intermediate shoe. Est TOC at 900'.
- 10/15/10 Tagged cement at 911'. Pumped 25 sx Class "C" cement at 149' and circulated to surface. ND BOP. Topped well off with cement.
- 10/26/10 Dug out cellar and cut off wellhead. Had to put 5 sx cement down 8-5/8" casing. Installed dry hole marker. Filled cellar back in and dug out anchors. Cleaned location. **WELL IS PLUGGED AND ABANDONED.**
