- Buried all electric lines.
- Overhead powerline has been staked and a right-of-way request will be submitted.
- Tanks were moved off location. Soiled areas were removed and hauled to CRI for proper disposal. Location was leveled. New 40 mil. liner was placed under tanks.
- Ground structures and equipment have been painted Shale Green (5Y 4/2).
- Berm has been built around tank battery and barbed wire fence has been installed around battery.
