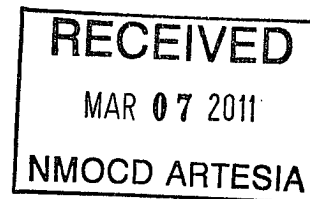

TIH. Tag PBTD @ 11,190'. Circulate hole clean with 260 bbls. 2% KCL TFW. NU BOP. Run GR/CBL/CCL from PBTD to TOC. TOC @ 2200'. Perforated 5 1/2" csg. 11071-11082' w/4 JSPF. Run 5 1/2" AS-IX packer, profile nipple, and On/Off tool. Set packer @ 10980'. Swab.

Acidize with 1000 gals. 15% HCL-NE-FE acid + 50 ballsealers. Flush with 2% KCL TFW. Maximum treating pressure was 4500 psig. Swabbing.
