5 1/2" 17# P-110 8rd LT&C set at 7500'

Stage 1 Cement: 550 sx PVL with 3% D174, .3% D167, .1% D65, .2% D46, .3% D800 mixed at 13.0 ppg (1.43 cf/sk)

Stage 2 Cement DV tool at 5000': 307 sx 35:65 Poz "C" with 5% D44, 6% D20, .2% D46, 2 pps D42, .125 pps D130 mixed at 12.6 ppg (2.05 cf/sk)
