March 12, 1975 - Ran 334.78' of 8-5/8" O.D. casing to 346.30'. Cemented with 250 sx Class H cement with 2% calcium chloride. Circulated out 10 sx. Plug down @ 3:45 A.M. 3-13-75. WOC 12 hrs. Press. Test 800#/30 min. Test O.K.

March 20, 1975 - Ran 2993.30' of 5 1/2" O.D. casing to 3000'. Cemented with 100 sx Class H salt saturated cement. Plug down @ 3:30 P.M. Calculated top of cement 2400'. WOC more than 72 hrs.

April 8, 1975 - Perforated San Andres P2 Zone 2954-64". Acidized w/1500 gals. 15% HCL. Swbd. load and recovered 12 bbis. salt water/8 hrs. Set Cast Iron Bridge Plug 2926'.

April 14, 1975 - Perforated San Andres P1 Zone 2888-98". Acidized w/1500 gal. 15% HCL. Swbd. load. N.S. Swbd. dry. Preparing to plug and abandon.
