After setting 8-5/8" casing at 965' with 200 sacks cement circulated to surface, we drilled to 1925' without encountering any additional water or shows of oil or gas. Pursuant to telephone conversation with Mr. Gresset this well was plugged and abandoned June 18, 1975 as follows:

50 sack plug from TD to 1680' across the Queen formation.
40 sack plug from 1000' to 880' in and out of the 8-5/8" casing.
10 sack plug and marker at surface.
Heavy mud in between plugs. Work done by Halliburton.
