5/12/77 Td 1950 PbTd 900. Left 8 5/8" csg. set @ 250' & circ. with 200 sxs and 4 1/2" csg. cemented with 700 sxs - circ. 100 sxs to surface, in hole. Did not retreat the Queen sand. Pulled tubing and rods. Ran tubing to 700 feet and spotted 15 sxs of cement over Queen perfs. 628 to 660. Pumped cement down with 25# mud. Set surface plug and marker with 5 sxs of cement. Due to muddy roads and the unavailability of dirt contractor with "cat", the final phase of clean-up was delayed.

6/18/77 Filled pits and levelled location. No caliche was used on access road or on location pad. Inspected location on 6/20/77 and location appear to meet all State requirements for abandonment.
