Cut 5 1/2" casing off at 682' and laid down. Picked up and ran 691' of 2" tubing. Got stuck and ran a Free-Point. Found tubing stuck at 682' at top of casing. After telephone conversation with Mr. Beekman pumped 40 sacks Class C w/2% CaCl. Cut off tubing at 675' and set a 35 sack Class C 2% CaCl plug. Waited 4 hours and tagged plug at 556'. Set a 35 sack plug @ 347' and tagged plug at 225'. Set a 10 sack plug at surface.

Instructions
