Class "C" 50-50 Poz Mix, 4% Bentonite, 2% ca. cl., 1/4# Celo Flakes, 5# salt. Followed w/200 sx. Class "C" w/2% ca. cl. Plug down 11:30 AM. Top of cement @ 1100'. WOC 18 hrs. Tested 1000# 30 min OK. Resumed drilling.
