The Lillie Federal #5 well was plugged September 7, 1985, in the following manner:

1. Tubing was run to a depth of 2255' and the hole was loaded with heavy mud.
2. A 35 sack plug Class "C" was spotted from 2250' back to approximately 1840'. Tagged plug to 1840'.
3. A 50 sack plug Class "C" was spotted from 1006' to 895'.
4. A 35 sack plug Class "C" was spotted from 300' to 200'. (Behind 4 1/2" casing).
5. A 10 sack plug Class "C" was spotted from 30' to surface.
6. A regulation marker was erected and the location was cleaned and leveled and the Bureau of Land Management was notified for final inspection.
