

This form is to be filed with the appropriate District Office of the Commission not later than 30 days after the completion of any newly drilled or deepened well. It shall be accompanied by a copy of all pertinent and instructive logs, the well and a summary of all reported tests conducted, including drill stem tests. All depths reported shall be measured by tape. In the case of directionally drilled wells, true vertical depth shall also be reported. For multiple completions, Items 23 through 24 shall be reported for each zone. The form is to be filed in quadruplicate except on state land, where six copies are required. See Rule 1165.
