

This form is to be filed with the appropriate District Office of the Division not later than 30 days after the completion of any newly-drilled or deepened well. It shall be accompanied by one copy of all electrical and other test logs run on the well and a summary of all reported test results, including drill stem tests. All depths reported shall be measured together, in the case of directionally drilled wells, true vertical depths shall also be reported. For multiple completions, from 10 through 14 shall be reported for each zone. This form is to be filed in duplicate except on state land, where six copies are required. See Rule 1105.
