Cemented casing with 200 sacks Class C cement with 2% C.C.

Cement did not circulate to surface.

On the 10-7-79 cemented down backside with 225 sacks Class C W/ 2% -CC.

Cement circulated to surface.

Left 200' of cement in pipe and did not get a Shut off on surface water.

Plan to squeeze off surface water.

Temporary shut down waiting on rig.
