This cause came on for hearing at 9 a.m. on June 4, 1980, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this <u>18th</u> day of June, 1980, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

## FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Yates Petroleum Corporation, seeks authority to complete its 5 Mile Draw Federal "LX" Well No. 1, located in Unit O of Section 34, Township 6 South, Range 25 East, NMPM, Chaves County, New Mexico, as a dual completion (conventional) to produce gas from the Abo formation through the casing-tubing annulus and gas from the Pennsylvanian formation through 2 7/8-inch tubing, with separation of the zones to be achieved by means of a packer set at approximately 4600 feet.

(3) That the applicant also seeks approval for the unorthodox location of said well in the Abo formation 800 feet from the South line and 2100 feet from the East line of said Section 34.

(4) That the mechanics of the proposed dual completion are feasible and in accord with good conservation practices.
