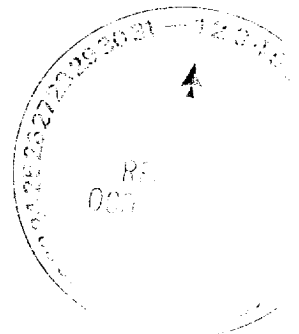

7. Set 100' cmt plug @ 810-910'.
8. Circ cmt from 170' to surface.
9. Cut off wellhead & install dry hole marker.

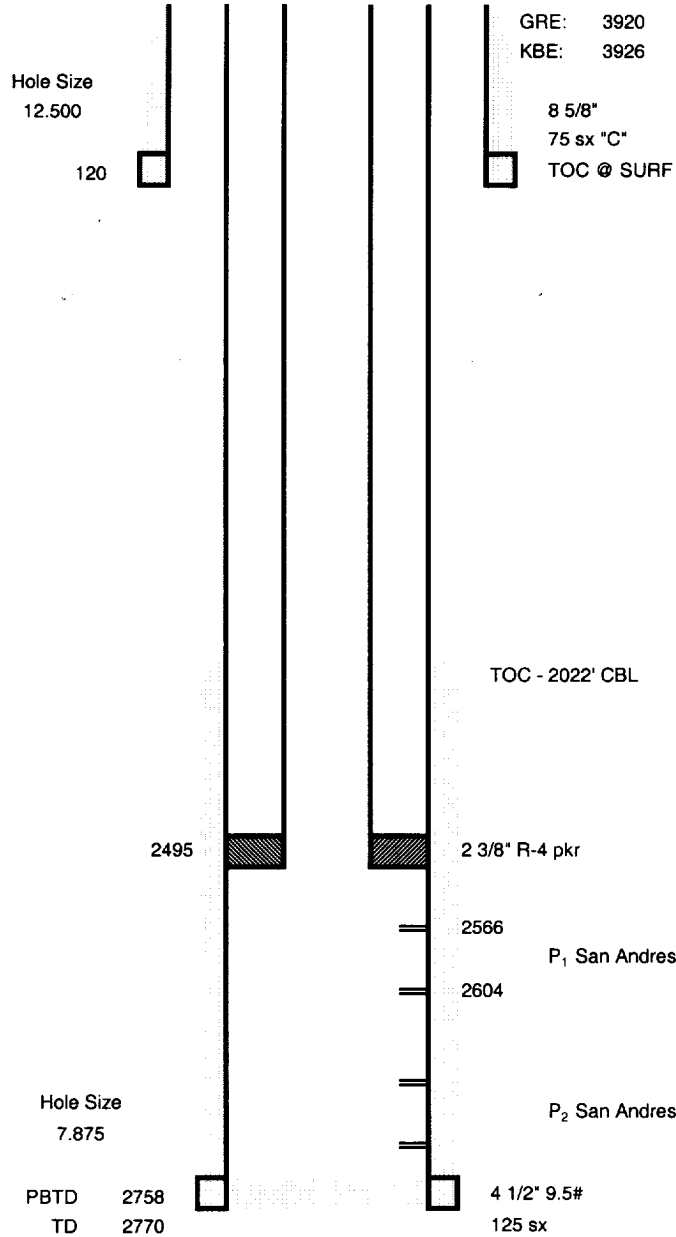
