YATES PETROLEUM CORPORATION RESPECTFULLY REQUESTS PERMISSION TO TEMPORARILY ABANDON AS FOLLOWS:

1. MIRU WSU & safety equipment. Bleed pressure off tubing & load tubing & casing w/ 30+/- bbls of 2% KCL water; ND wellhead & NU BOP. POH w/ tubing & seat nipple; pump 2% KCL water only as needed to keep well dead.
2. RU wireline & RIH w/ 4-1/2" gauge ring to 3350' to make sure casing is clear, then run 4-1/2" CIBP & set plug @ 3350' - cap plug w/ 35' of cement. RD wireline.
3. RIH w/ tubing to 3315' & circ hole w/ 10.0 ppg brine plugging mud w/ 25# of gel/ bbl mud then close BOP & test casing to 500 psig for 30 minutes and record a chart for NMOCD. POH laying down tubing; cap wellhead & temporarily abandon the well.
