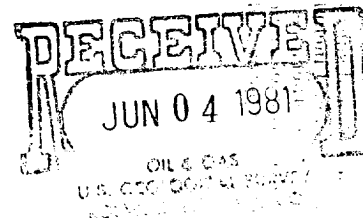
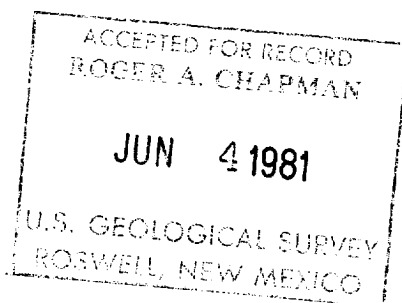

Drilled 11" hole to 1762' on 5-30-81. Ran 39 jts 8 5/8", 24#, K-55 casing set at 1758'. Cemented with 500 sx LT + 1# flocele + 4% CaCl, 200 sx Thixset + 4% CaCl, and tailed in with 300 sx "C" + 2% CaCl. PD at 10:00 PM 5-30-81. Circulated 150 sx to surface. WOC 18 hours. Tested BOPs and casing to 600 psi for 30 min - OK. Reduced hole to 7 7/8" and drilled ahead on 5-31-81.

Instructions
