It shall be accompanied by one copy of all electrical or lithologically log run on the well and a summary of all special tests conducted, including BHU stem tests. All depths reported shall be measured depth. In the case of horizontally drilled wells, true vertical depth shall also be reported. For multiple casing bottoms, Item 20, Paragraph 4 shall be reported for each zone. The form is to be filed in quadruplicate except on state land, where six copies are required. See Rule 1105.
