- 3) Fluid level Sonic test between tubing and casing as per Memo to File 203-C.

McClellan Oil requests permission to run a fluid level Sonic test in lieu of a casing integrity test as putting fluid on the formation would be detrimental to the producing zone.

These tests will be conducted within 90 days of approval and subsequent to notification being given to the BLM.
