Yates proposes to temporarily abandon this well, to hold for future deepening.

Propose to temporarily abandon as follows:

Notify BLM 24 hours before commencing work.

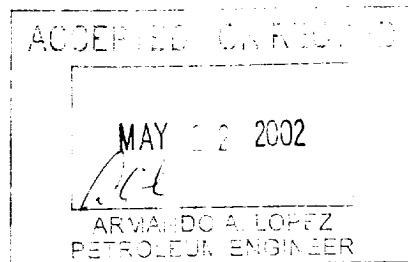
Release packer set at 3472'. POOH with packer and tubing.

Set CIBP at 3500' capped with 35' cement.

Load hole with 10 pps brine plugging mud with 25 lbs of gel per bbl.

Pressure test casing to 500 psi and record chart for 30 minutes. Submit chart to the BLM.

If well fails pressure test, make decision on whether to locate leaks, or plug and abandon.
