

Move in and rig up Tyler Well Services pulling unit. Move in and rig up reverse equipment. Make up 7 7/8" bit, 8-4.75" drill collars and go in hole. Pick up tubing and tag at 2995'. Pick up swivel and circulate out fill to 2998'. Drill cement from 2998' to 3036' and fall free. Continue in hole at tag at 3552'. Circulate hole clean. Pull out of hole and lay down drill collars. Rig down and release pulling unit and the rental equipment on 2-13-99. Well shut in with BOP.
