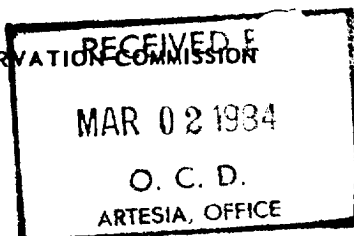

A 7 5/8" hole will be drilled to approx. 2340'. Density and Induction logs will be run and depending on the outcome of the well, it will be P & A'd or 4 1/2" casing will be run.

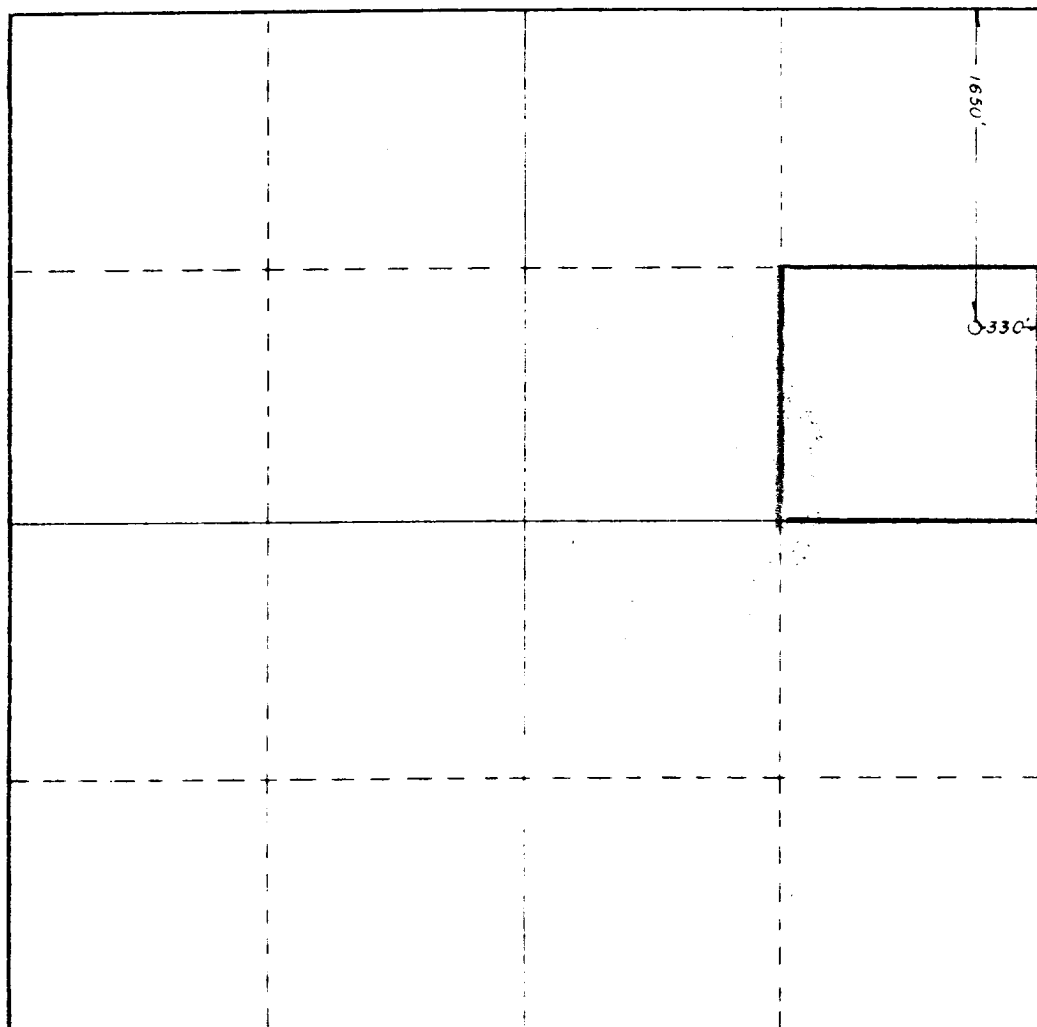
