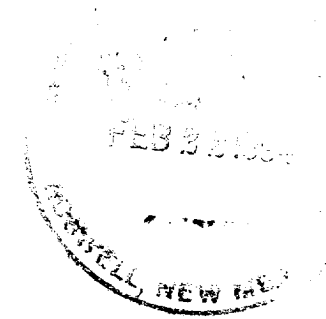

Existing Circumstances: PBTD is 6,506'. Present perfs: one at 6,490.5' and one at 6,498.5'. 5 1/2" production casing runs from the surface through PBTD. Surface casing (8 5/8") runs from surface to 1,643'. Estimated top of cement behind production casing is 4,500'. Hole from surface casing to TD is 7 7/8".

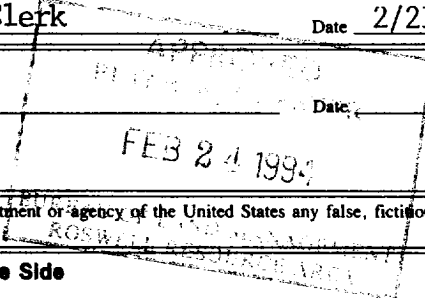

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

SPECIFIC INSTRUCTIONS
