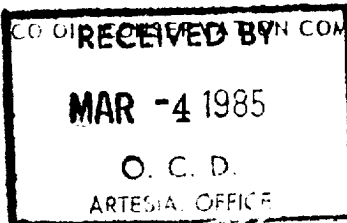

We plan to drill a 10" hole to 320' and set 8 5/8" casing, texas pattern guide shoe and 2 centralizers and insert float. 8 5/8" casing will be cemented with 200 sx Class C cement circulated to surface. A 7 5/8" hole will be drilled to approximately 2300' and a Deviation Survey will be run. Density and Induction logs will be run. Depending on the outcome of the well, it will be P & A'd or 4 1/2" casing will be set.

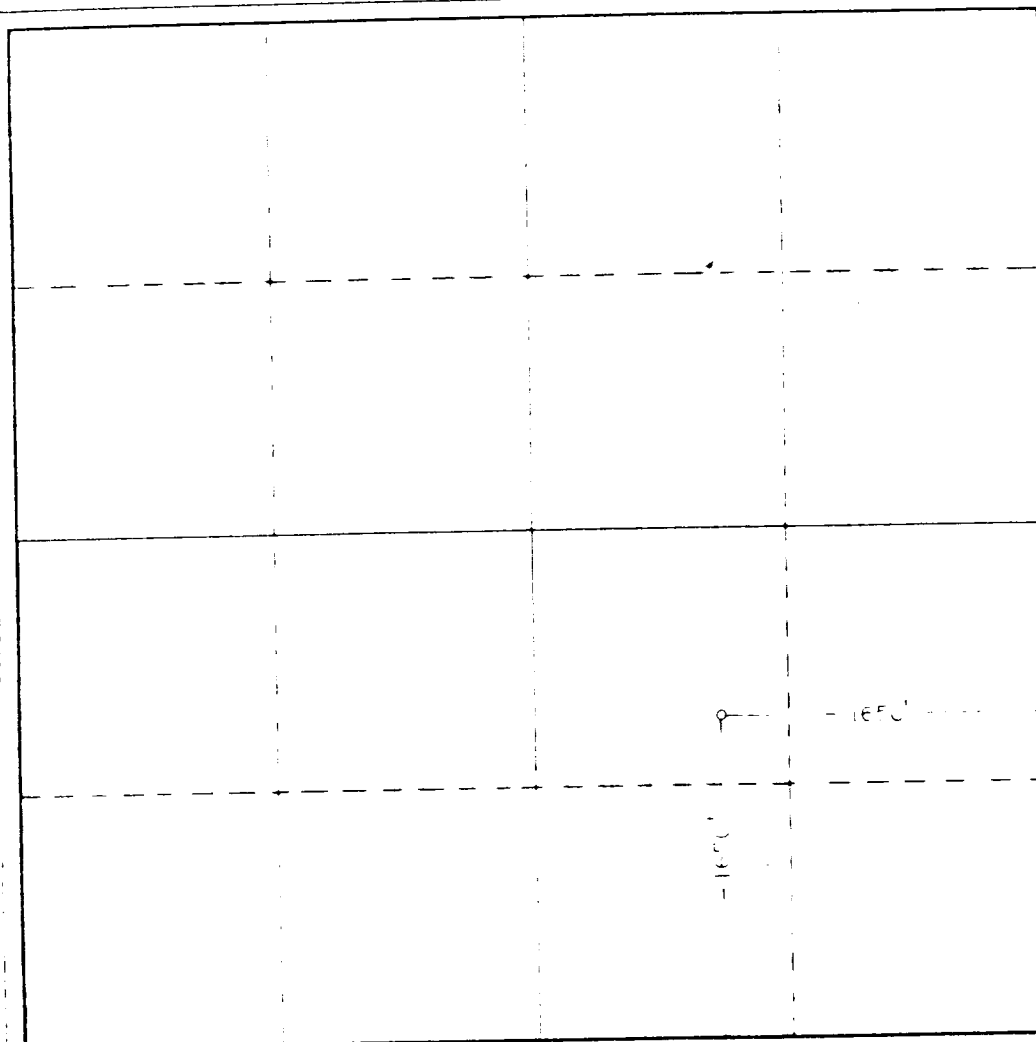
