On November 5, 1985 oral approval to plug and abandon was obtained from Mr. Peter Chester with the Bureau of Land Management Roswell District. The well was plugged and abandoned due to a lack of commercially economical quantities of oil or gas. The total depth of the well was 9600 feet. The mud used in plugging was a brackish mud, 9.4 ppg, 40 Vis, 21,000 ppm chloride. The following cement plugs were set using open-ended drill pipe:

Plug No. 1 - 9510' to 9360' - 45 sacks Class "A"
Plug No. 2 - 8050' to 7900' - 55 sacks Class "A"
Plug No. 3 - 5775' to 5625' - 55 sacks Class "A"
Plug No. 4 - 2350' to 2250' - 36 sacks Class "A" + 2% CaCl
Plug No. 5 - 350' to 250' - 30 sacks Class "A"
Plug No. 6 - 50' to 0' - 15 sacks Class "A"

Set dry hole marker and finished plugging on November 6, 1985. Plug No's 1 and 4 were tagged with drill pipe to verify the depth.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
