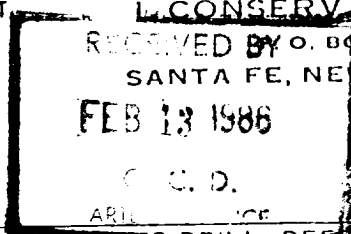

We plan to drill a 12 1/4" hole to 300' and set 8 5/8" casing. 8 5/8" will be cemented with 200 sx Class C cement circulated to surface. A 6 1/2" hole will be drilled to approximately 2300'. Logs will be run and 4 1/2" casing will be set or the well will be p & A'd depending on the outcome of the logs. A deviation survey will be run.

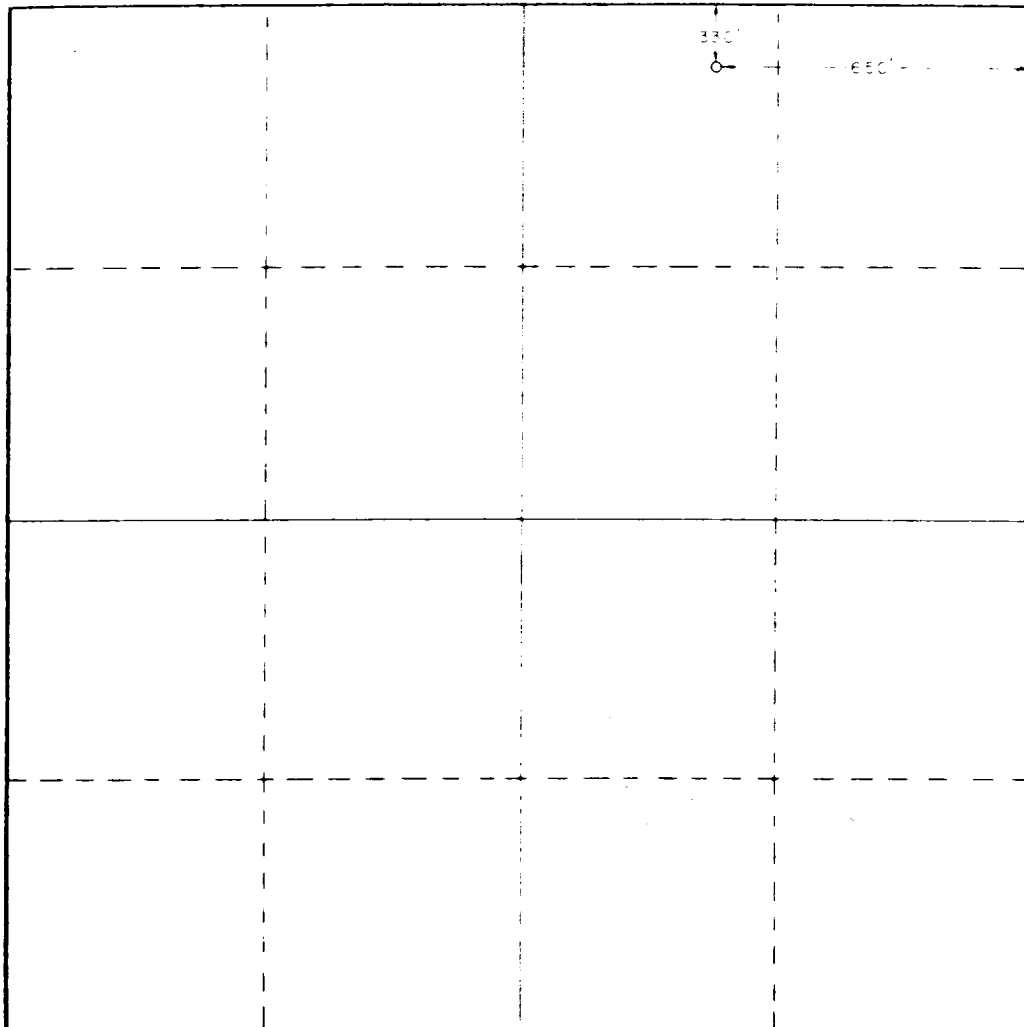
