McKay Oil Corporation proposes to perforate the Inxco Federal 4 upper zone at 2915-2921 (6 shots) and at 2948-2952 (4 shots) as well as treat the perforation interval via 2 7/8 tubing at a rate of 15 BPM and max anticipated surface treatment pressure of 3000 psi or 2500 psi respectively with 1000 gallon 7 1/2% HCL and 36,000 gallons 18 lb CMHPG-XL foam containing 101,000 lbs of 16/30 mesh.

If CO2 job, will be 50:50 CO2 to fluid. If it is N2 foam, the pad, 2 lbs and 3 bls/gel will be 75 Q foam. 4 lbs/gel stage 70 Q foam and 6 lbs/gel 55 Q foam. Fluid will consist of 2% KCL and 20-25% by volume methanol.
