

McKay Oil Corporation plans to re-enter this well, ^{Set} a bridge plug and re-drill the well as a horizontal well. The lateral that will be drilled will be open hole from entry into the Abo Formation to the total length of the lateral.

The lateral will be drilled approximately 3000' in a West-Northwest direction from the vertical hole terminating in the SW/4 Quarter of Section 17, T6S, R23E.


