DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Plugged back from total depth of 7010' to 6711' with 30 sacks cement. Ran DST 6900-6711', tool open 1 hour, recovered 120' drilling mud - no oil or water. Filled hole with heavy mud to bottom of 7-5/8" casing. Set cement plug in bottom of casing from 3085-3185' with 20 sacks cement. Filled hole to surface with heavy mud. Cemented 4 1/2" iron marker pipe in top of casing, cemented up cellar, and leveled location.
