2. That Socony Mobil Oil Co., Inc. the operator of a well drilled on land be-

New Mexico, said well being drilled to test for hydrocarbons and/or
carbon dioxide gas and described as the Ralph O. Pearson No. 1, being located 660

3. That said well was drilled to a total depth of 7722 feet, and that cas-
ing has been set and cemented as follows:
