2-16-62 Ran 10 joints 13 3/8" 48# H-40 casing as surface pipe. Set at 317' and cemented with 100 sx. reg. W/25# gilsonite and 2% NA-5, followed by 200 sx. reg. W/2% NA-5. Cement did not circulate. Pumped 300 sx. Reg cement down annulus.

2-17-62 Tested plug with 1000# for 30 min. O.K.

2-27-62 Ran 118 joints 8 5/8" O.D. 32# casing. Set at 3740' with stage collar at 1548'. 1st stage cemented with 153 sx. 50-50 pozmix reg. W/18% gel and 3% salt followed by 325 sx. 50-50 Incer Pozmix 8 W/2% calcium chloride. 2nd stage cemented with 153 sx. 50-50 Pozmix reg. W/18% gel and 3% salt followed by 110 sx. 50-50 Incer Pozmix W/2% gel.
