THE SULIMAR QUEEN UNIT IS AN OILFIELD USED FOR RESEARCH BY THE PETROLEUM RECOVERY RESEARCH CENTER, A DIVISION OF THE N.M.I.M.T. DURING THE PAST YEAR A INNER WELL SEISMIC PROGRAM HAS BEEN PERFORMED, MULTIPLE PRESSURE TESTS AND CURRENTLY A SERIES OF TRACER/PRESSURE TESTS ARE BEING DESIGNED TO BE PERFORMED THIS SUMMER. IT IS IMPORTANT TO THIS RESEARCH EFFORT TO MAINTAIN AS MANY USABLE WELLBORES AS POSSIBLE.

THEREFORE, SINCE RULE 203 HAS BEEN COMPLIED WITH, WE RESPECTFULLY REQUEST AN EXTENSION OF THE T.A. STATUS UNTIL JUNE OF 1996.
