ON JUNE 25, 1992 A DOWN HOLE CASING INTEGRITY TEST WAS PERFORMED. THE WELL HELD 500 PSI FOR 30 MINUTES, THUS PASSING THE TEST.

A T.A. STATUS WAS APPROVED FOR ONE (1) YEAR, FROM JULY 16, 1992 TO JULY 16, 1993.

NORMALLY THE CASING INTEGRITY TEST COVERS A FIVE YEAR PERIOD. THEREFORE, THIS WELL WILL HAVE TO BE RETESTED IN JUNE OF 1997. SINCE RULE 203 HAS BEEN COMPLIED WITH, WE RESPECTFULLY REQUEST AN EXTENSION OF THE T.A. STATUS UNTIL JUNE OF 1997.
