DURING THE PAST YEAR A TRACER/INTERFERENCE TEST WAS PERFORMED ON #1-16 AND #1-3. IN JULY 1996 A OIL SOLUBLE TRACER/WETTABILITY TEST WILL BE PERFORMED ON #1-16. IT IS IMPORTANT TO THIS RESEARCH EFFORT TO MAINTAIN AS MANY USABLE WELLBORES AS POSSIBLE.

THEREFORE, SINCE RULE 203 HAS BEEN COMPLIED WITH, WE RESPECTFULLY REQUEST AN EXTENSION OF THE T.A. STATUS UNTIL JUNE OF 1997


