Cemented with 540 sxs Interfill C + 5 pps gilsonite (yld 2.42, wt 11.9). Tailed in with 200 sxs P + C with 2% CaCl2 (yld 1.34, wt 14.8). PD at 7:00 PM. Bumped plug to 1300 psi, held OK. Circ 135 sxs. WOC.

7/14/01 - Drilled out at 4:30 PM. WOC 21 hours 30 mins. Reduced hole to 7-7/8" and resumed drilling.
