- 1). Set a CIBP at 1400' to isolate perforations(1425'-1433'). Circulated well with 25# Salt Gel per BBL of mud. Test casing to 500 PSI.
- 2). Set a 10sx Class "C" cement plug from 1400' to 1250'.
- 3). Set at 250'. Set a 20sx Class "C" cement plug from 250' to surface.
- 4). Install Dry Hole Marker and clean location.
