O.T.D. 465' Lime. It is proposed to plug and abandon this well in the following manner:

1. MIRU a pulling unit and POOH rods and pump. Kill well, if necessary, ND WH and POOH w/tubing.
2. RIH w/2-3/8" OE tubing and pump a 100 sack (100') Class C w/50# Flocele + 500# Gilsonite + 3% CaCl₂ cement plug @ T.D. 465 - + 365'. POOH w/tubing and WOC.
3. RIH w/2-3/8" OE tubing, tag cement plug, and pump a Class C Neat cement plug until cement circulates to the surface. POOH w/tubing.
4. CO WH, RD pulling unit, and install a 4" dry hole marker to designate a plugged and abandoned location.

If needed, fill outside of csg w/cement.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
