Dear Sir:

Please find enclosed plat of the acreage jointly owned by Mr. Roland Rich Woolley and Mr. J. R. Metcalf.

They propose to drill a wildcat well in SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 31- T16R- R27E.

This will be a shallow well to 4,000 feet. We will set approximately 250' of 13 3/8" and approximately 2,000' of 9 5/8" casing with a rotary, under the supervision of the Artesia Water Commission at Roswell. Then we will move in cable tools to drill to the above mentioned depth.

Should this be dry at 4,000', we will have a hole that can be deepened with a large rotary rig. Therefore, we are asking for exception to Rule No. 104, in regard to spacing of deep wildcat wells, for the following reasons:

Mr. Woolley and Mr. Metcalf own the acreage to the north, west and south, and are 990' from the east acreage, which is owned by Continental Oil Company.

The well was also located here to stay off the irrigated farm land and out of the flooded area. When the Pecos river is out of banks it will not come up to this location. It is also 300' from a raised all-weather road.

This location will prove six 40 acre tracts owned by Mr. Woolley and Mr. Metcalf, should we get production.

The tanks can be located on high ground on this same 40 acre tract.
