It is my opinion that if we were to perforate additional sections that more gas could be produced from this well; however, at this time I am unable to secure a connection without additional development on this lease. Therefore, I plan to shut this well in as a shutin gas well, if this is acceptable to the UICM until further development can be achieved on this lease. In order for this development to take place it will be necessary that this lease be stipulated in order that we may do additional drilling on this lease.

CONDITIONS OF APPROVAL, IF ANY:

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
