On May 11, 1965, this well was perforated in the next intervals as set forth on the
Notice of Intent, and was acidized with 1,000 gals. 10% hydrofluoric acid sealers.
This well was scrubbed on May 11 and 12, 1965, recovering all lost acid and
making an undetermined amount of gas estimated to be approximately 200 MCF per day.
No oil was indicated.

Therefore, the decision was made to plug and abandon.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
