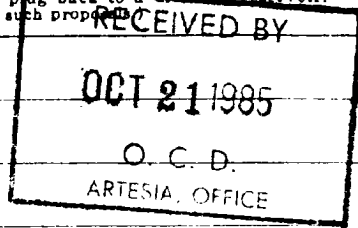

Water Injection Well, 7" Casing set at 558. (Open hole from 558 to 590-T.D.)

Filled hole from TD to 560 W/Frac Sand and dumped one bailer of cement on sand to protect formation. Ran 557' 4" API pipe and circulated cement to surface. Drilled out plug and circulated out sand. Ran Plastic coated Packer and 2 3/8 Tubing to 550'. Well is now ready to test and put on injection. Work was completed 10-3-85. Kcl water was used behind tubing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
